

## LED PRODUCTS WARRANTY POLICY

France Lighting Solutions, a Marmon Power Systems brand, warrants its LED Products to be free from defects in material and workmanship at the date of shipment and for the warranty period stated below. This warranty is conditional based upon proper installation, use and maintenance of the product. This warranty is not applicable to any product not installed and operated in accordance with France specifications and connection diagrams or which have been subjected to abnormal operating conditions.

### Limitation of Liability

NO other warranty, whether express or implied, including any warranty of merchantability or fitness for a particular purpose, shall exist in connection with the sale or use of such products. Without limiting the generality of the foregoing, the Company shall under no circumstance be liable for any incidental or consequential loss or damage whatsoever arising out of, or in any manner related to, any such breach of warranty or claimed defect in, or nonperformance of, the products. The Company shall not be responsible for any other costs, including installation or field support labor or loss of profits, income or revenue.

### Usage

This warranty is conditional based upon proper use, installation and wiring in accordance with instructions provided, and use in applications and environmental conditions for which they were designed. This warranty does not apply to any abnormal use or any installations which do not comply with the National Electrical Code, Underwriters Laboratory Standards, Canadian Standards Association or any local or regional code guidelines. France technical support is available to assist with any information or troubleshooting assistance as may be required.

### Warranty Claims

All claims under this warranty must be made in writing and delivered to the Company prior to the expiration of the established warranty period from date of manufacture. In the event a product fails under the stated warranty period, contact Customer Service at [sales@francelighting.com](mailto:sales@francelighting.com) or 800-793-4793 for a RGA (Return Goods Authorization) number and instructions. The RGA shall be valid for a period of 30 days. All shipping boxes and packing slips must be marked with the RGA number and a copy of the approved RGA form must be included with the shipment. The Company shall inspect and examine all products claimed to be defective to evaluate proper usage, determine the cause of failure, and make a determination, in its sole judgment whether the products are defective and covered by this warranty. The Company shall, at its option, replace free of charge any product determined to have been defective at the time of shipment from the factory. If circumstances are such as to preclude the remedying of warranty defects by replacement, the Company shall, upon the return of the products, refund to the original buyer any part of the purchase price paid to the Company for the stated products. Inspection shall be performed at the Company's plant or at such other place as may be designated by the Company; and, freight for returning products for inspection shall be paid by the buyer, unless otherwise specified on the RGA form. The foregoing shall constitute the exclusive remedy of the purchaser and the sole liability of the Company.

### Standard Limitations and Exclusions

**Five (5) Year Product Limited Warranty:** Valid from the date of manufacture or from the date of registered installation, and covers defects in material and workmanship.

**One (1) Year Limited Labor Warranty:** Effective within twelve (12) months of installation on Units having a 2017 Date Code or later. Up to a max amount of \$100.00 per service location regardless of number of units used or job size. All products submitted for Labor Warranty must be returned for testing and evaluation. Installation date and failure date must be provided for the claim to be processed. A Labor Credit will be issued for products deemed to be defective within the stated warranty period. A product shall not be defective solely as a result of the failure of individual LED components contained in the product if the total number of inoperable components is less than fifteen percent (15%) of the total number of LEDs in the product.

A replacement unit can be obtained immediately through our distribution partners.
